4 and 5. Comparative regionalism

Levels and ways of regional integration differ depending individual regions. The sessions compare regions in the world from the perspective of regional integration and discuss the basic causes of divergence among them.

6 and 7. Economic rationale of regional integration: Static and dynamic effects.

This session first overviews the types of regional integration: preferential trade agreement, free trade agreement, customs union, common market, monetary union, and political union. Subsequently introduces the static welfare effects based on the traditional customs union theory, and provides the analytical framework for the following sessions.

8. New regionalism and globalisation

The beginning of the 1990s afterwards saw the resurgence of regional integration in Europe and north America as well as developing regions including Africa. Why did the 'traditional' regionalism in the 1960/70s receded and resurged after 20 years. This session discusses the trajectory of the new regionalism and its dynamic effects within the context of globalising world economy.

The rise of new regionalism is discussed in the context of the history of multilateral trade liberalization process with particular reference to the US trade policy, the decision-making system of the World Trade Organisation and the conflicting interests between developing and developed economies.

10 and 11. Development and regionalism

Asia, Latin America and African countries promote regional integration with developed economies such as Europe and north America as well as with neighbours. This session examines the regional integration as the means of industrialisation and agglomeration through promoting investment for developing countries.

12 and 13. The issues in regional integration of developing countries

Provision of regional integration agreement between developing countries, Africa in particular, tends to be less ambitious; implementation of such agreement as well as the performance of trade and investment are generally disappointing, being far from the original intension. This session explores the issues which Africa's regional integration schemes face, e.g. historical context, constraints of economic structure and size, governance and overlapping membership.
